

**The Trustee for Amy Gillett Foundation Trust T/A Amy Gillett Foundation  
Road Right Program 2009 - 2010  
Terms and Conditions**

1. Information on how to enter forms part of the terms of entry. Entry into the competition is deemed acceptance of these terms and conditions.
2. Entry is open to all residents of Australia who hold a valid car drivers licence learners permit and accredited driving instructors. However, employees and their immediate families of Amy Gillett Foundation and their associated agencies and companies are not eligible to enter.
3. The competition commences on 20 July 2009 at 00:01 (AEST) and concludes on 30 June 2010 at 23:59 (AEST).
4. To enter, participants must log onto [www.amygillett.org.au](http://www.amygillett.org.au) and register their details including (but not limited to) name, address, phone number, e-mail address, learners drivers licence number along with the correct answers to the Road Right Quiz.
